

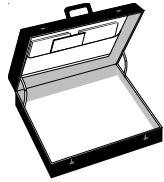
This Associate in Arts degree program is designed for those students who expect to transfer and earn a degree in the College of Business at the University of Florida.

### Entrance Requirements

A minimum overall GPA and a minimum on all attempts of preprofessional courses are required for admission to the College of Business. GPA requirements vary by major; most are 3.0 or higher. Check the UF ISIS website for specifics. All prerequisites must be completed before enrolling at UF. The College of Business will recompute your GPA based on all attempts on all critical tracking courses. The courses in BOLD are critical tracking courses for this major at UF.

The University of Florida will deny admission to any student who has not satisfied the state foreign language admissions requirement.
