MEANS OF ACCOMPLISHING STUDENT LEARNING OUTCOMES:

Online course

The instructor will introduce students to the tools, materials, and techniques used to create a portfolio and resume for the theatre via a combination of assigned text, videos, exams, and out-of-class assignments. Successful completion of this course will determine student's ability to continue in the program. Each student will be expected to read all assigned material as well as complete all assignments. The instructor will provide timely feedback on assignments and provide contact information to address further questions and student needs. The final grade will be based on quizzes, threaded discussions, proctored exams, a proctored cumulative final exam and a completed portfolio project.

Students are expected to:

- Read all assigned readings of text, plays and outside sources
- Turn in assignments on time
- Participate in discussion boards
- Complete all quizzes, projects and final exam

Make-up work is the responsibility of the student, as covered in the instructor's First Day Handout.
