#### Indicators of Accomplishing Chipola's Mission of Facilitating Regional Development

The mission of Chipola College is to provide "access to quality learning opportunities toward baccalaureate degrees, associate degrees, and certificates and to [facilitate] the economic, social, and cultural development of the college's service area." Goal seven in the college master plan is to facilitate regional development. This issue of *Chipola College Facts!* examines program offerings, student achievement outcomes, and survey results that indicate the extent to which the college is accomplishing its mission pertaining to economic, social, and cultural development in the region.

#### **Facilitating Regional Development**

An examination of college program offerings in relation to regional projected job openings provides evidence that college programs are aligned with economic and workforce development needs.




Evidence of Chipola's support of regional economic development is also found in career and technical education completer employment placement rates and licensure/certification exam pass rates. The target levels for employment placement and licensure/certification exam pass rate identified in priority outcomes of the college master plan was 95%. As shown in the following graphs, Chipola's placement and pass rates have approached or exceeded the 95% target for several years.

#### Certification/Licensure Exam Pass Rates: All Programs (All Attempts)




Additional evidence of economic development is provided by the survey of career program advisory committee members. When asked their level of agreement regarding Chipola's career-focused programs having a positive impact on the regional economy, 100% of committee members replied "agree" or "strongly agree" in the 2023-24 survey.

Evidence that Chipola facilitates social and cultural development in the region is found in survey responses. The following graphs illustrate the response means on employee and student survey items


associated with Chipola's contribution to social and cultural development as well as to overall quality of life in the region.

Scale: 5 = strongly agree, 4 = agree, 3 = average, 2 = disagree, 1 = strongly disagree



Scale: 4 = very much, 3 = quite a bit, 2 = some, 1 = very little


