MAXIMUM AWARD OF CREDIT

As guaranteed by the Statewide Career Pathway Agreements, this agreement guarantees a student to receive nine (9) semester hours of college credit towards the AS Network Systems Technology Server Administration degree at Chipola College upon successful completion of the Network System Administration or the Network Support Services clock hour programs at Florida Panhandle Technical College. This agreement guarantees eleven (11) semester hours of college credit towards the AS Nursing R.N. at Chipola College upon successful completion of the Practical Nursing clock hour program at the Florida Panhandle Technical College and an active Florida or Multistate LPN license . In accordance with 1007.233, F.S. this agreement may not award less credit than the amount guaranteed through existing statewide articulation agreements.

EDUCATIONAL PROGRAM

Chipola College and Florida Panhandle Technical College have assessed the adequacy of the documentation and determined that the learning outcomes, performance standards and assessment procedures meet the college standards for college credit course work and that the learning outcomes are:

1. Consistent with the course work in the AS degree being articulated.
2. Based on the Career Certificate Program to AS/AAS Degree Statewide Career Pathways Agreement.

ADMISSION PROCESS

1. Apply for admissions to Chipola College and meet the College entrance requirements.
2. Submit a completed Chipola College application for admission, satisfy the requirements for Degree-Seeking Status, including submission of all official transcripts, and declare a major in the articulated program.

3. Be accepted into Chipola College within three years of completing the Florida Panhandle Technical College program. (*Note: If it's been longer than 3 years, an exception will be considered if the student can demonstrate they have current industry knowledge (i.e. through an employer letter, etc.)*)
4. Comply with the appropriate placement, course prerequisites and requirements of the college.
5. LPN applying to the AS Nursing R.N. and admission to the second semester of the ADN program must:
 - 1) Meet all current ADN requirements for admission, including all prerequisite coursework (BSC 2085 & Lab, BSC 2086 & Lab, ENC 1101, MAC 1105, PSY 2012, & SLS 1101)
 - 2) Submit an application for the ADN program
 - 3) Have an active Florida or multistate LPN license

Transferring Process

To have the courses reported on the official Chipola College transcript, transferring students must do the following:

1. Students in the AS Network Systems Technology Server Administration major may apply to the Chipola College Registrar, following the successful completion of 12 college credits and Orientation. Students must maintain a cumulative GPA of 2.0 while enrolled in the AS Network Systems Technology Server Administration major. Students will meet with the Chipola College Registrar to verify completion of the clock hour program and a passing grade of 70% for each course in the clock hour program. It is the responsibility of the student to initiate this process, by completing a Career Pathway Agreement Form.
2. Students in the AS Nursing R.N. may apply to the Chipola College Registrar to receive credit for the first semester nursing courses (11 college credits) once they have successfully completed the AS Nursing R.N. program and have applied for graduation from the program. Students will meet with the Chipola College Registrar to verify completion of the clock hour program and an active Florida or Multistate LPN license. It is the responsibility of the student to initiate this process, by completing a Career Pathway Agreement Form.

3. After verifying the required documentation and evaluating the approved assessments(s), the Chipola College Registrar will award the college credit as transfer credits to Chipola College. Awarded college credits will be assigned a (P) Passing, this will be calculated in the cumulative GPA as equivalent to a "C" grade.


