PROGRAM ELIGIBILITY CHECKLIST

Application Deadline follows the College Application Deadline as posted!

- Complete an Associate in Arts Degree or at least 60 semester credit hours of postsecondary education with completion of the Chipola College general education requirement from a regionally accredited institution.
- Complete the following prerequisites, ECO 2013, ECO 2023, MAC 2233, STA 2023 or STA 2122 or QMB 2100, CGS 1100, ACG 2021, ACG 2071
 - ❖ Students seeking admission to the Accounting Track must complete ACG 2021 and ACG 2071 with a grade of “B” or higher.
- Cumulative grade point average of 2.0 on a 4.0 scale in all postsecondary coursework.
- Completed the state-mandated business common prerequisites as listed on the program curriculum guide.
- All upper level course work requires a grade of “C” or higher.

ADMISSION PROCEDURES

1. New students must submit a Chipola College general application for admission.
Former Chipola students, who have not attended Chipola in the past year, must submit an updated Chipola College general application for admission.
2. All applicants must complete the Baccalaureate Supplemental Application.
3. All applicants must request official transcripts from high school or a GED.
4. All applicants must request official transcripts from all previous institutions (not including Chipola College).

In compliance with Florida Statute 119.071(5), Chipola College issues this notification regarding the purpose of the collection and use of your Social Security Number. The college collects your Social Security Number for use in the performance of the College's duties and responsibilities. To protect your identity, the college will secure your Social Security Number from unauthorized access. The college will never release your Social Security Number to unauthorized parties. Federal legislation relating to the Hope Tax Credit requires that all postsecondary institutions report the Social Security Number of all postsecondary students to the Internal Revenue Service. This IRS requirement makes it necessary for colleges to collect the Social Security Number of every student. A student may refuse to disclose his/her Social Security Number to the College, but refusing to comply with the federal requirement may result in fines established by the IRS. In addition to the federal reporting requirements, the public school system in Florida uses the Social Security Number as a student identifier. This use is authorized by Florida Statute 229.559 and in School Code Section 1008-396.
