- ³ FSU requires an international/diversity course for graduation. It is strongly recommended that one of these courses be completed before earning the AA degree.
- ⁴ Must be completed with a grade of "C" or better. Accounting Majors must complete ACG 2021 & 2071 with a "B" or better.
- ⁵ Prerequisite for CGS 1100 is CGS 1060 or CIS 1000 with a "C" or better or an acceptable score on the CGS 1100 Screening Exam.
- ⁶ In addition to ACG 2021 and ACG 2071, students must also complete the Accounting Competency Examination with a score of 75% or higher before they can enroll in upper-level accounting courses.
- ⁷ If student has taken 2 credits of Foreign Language in high school then choose elective.
